In 2013, Agilent announced plans to separate into two publicly traded companies through a spinoff of its Electronic Measurement Group (EMG). The new name for EMG will be Keysight Technologies, Inc. Keysight expects to begin conducting business under its new name on Aug. 1, 2014.

Service Agreements	Keysight will honor the terms and coverage of post-sales service agreements (Balanced, Volume, Serialized or Custom Agreements) arranged with Agilent's Electronic Measurement Group service and support organization. All information on these agreements will be transferred from Agilent to Keysight by Aug. 1.
