Calibrated Class A glassware is used for volumetric measurements. Thermometers are calibrated against a NIST traceable thermometer in accordance with NIST Special Publication 1088.

Homogeneity:

This RM was unitized according to an in-house procedure and is guaranteed to be homogeneous. There is no minimum sub-sample size required.

Intended Use:

This RM is intended for the preparation of working reference samples for use in routine laboratory analyses, calibration of instruments, validation of analytical methods, assessments of measurement methods, and continuing calibration verification. □
