Personal precautions, protective equipment and emergency procedures

Methods and materials for containment and cleaning up

Precautions for safe handling

Avoid the creation of dust when handling and avoid all possible sources of ignition (spark or flame). Prevent dust accumulation. Use only with adequate ventilation.
