### 4.1 Description of necessary first aid measures

### 5.2 Special hazards arising from the substance or mixture

- Specific hazards arising from the chemical** : Highly flammable liquid and vapor. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. The vapor/gas is heavier than air and will spread along the ground. Vapors may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back. Runoff to sewer may create fire or explosion hazard. ### 8.2 Exposure controls

- Appropriate engineering controls** : Use only with adequate ventilation.
