## Section 4. First aid measures

### 4.1 Description of necessary first aid measures

Store bulk masses greater than 0.058 kg/0.1276 lbs at temperatures not exceeding 25 °C/77 °F. Eliminate all ignition sources. Store away from other materials. Maintain air gap between stacks/pallets.
