6.1 Personal precautions, protective equipment and emergency procedures

6.3 Methods and materials for containment and cleaning up

Methods for cleaning up : Stop leak if without risk. Move containers from spill area. The spilled material may be neutralized with sodium carbonate, sodium bicarbonate or sodium hydroxide. Absorb spillage to prevent material damage. Dispose of via a licensed waste disposal contractor.

7.1 Precautions for safe handling

Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Keep away from alkalis. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink. Store in a corrosion resistant container with a resistant inner liner. Separate from alkalis. Keep away from metals. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers.
