Section 4. First aid measures

4.1 Description of necessary first aid measures

5.3 Advice for firefighters

Special protective actions for fire-fighters : Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. 6.1 Personal precautions, protective equipment and emergency procedures

7.1 Precautions for safe handling

8.2 Exposure controls

- Appropriate engineering controls** : Use only with adequate ventilation.
