## Section 3. Composition and ingredient information

Note: The hazard information listed is based on unbonded silica gel CAS Number 112926-00-8. To the best of our knowledge, the acute and chronic toxicological properties of bonded silica gels have not been investigated. This product contains synthetic amorphous silica, and should not be confused with crystalline silica such as quartz, cristobalite, or tridymite, or with diatomaceous earth or other naturally occurring forms of amorphous silica that frequently contain crystalline forms of silica.

## Section 4. First aid measures

### Description of necessary first aid measures

## Section 5. Firefighting measures

## Section 6. Accidental release measures

### Personal precautions, protective equipment and emergency procedures

### Precautions for safe handling

Wear appropriate respirator when ventilation is inadequate. Electrical equipment and lighting should be protected to appropriate standards to prevent dust coming into contact with hot surfaces, sparks or other ignition sources. Take precautionary measures against electrostatic discharges. To avoid fire or explosion, dissipate static electricity during transfer by earthing and bonding containers and equipment before transferring material.

**Conditions for safe storage, including any incompatibilities** : Store in accordance with local regulations. Store in a segregated and approved area. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink. Eliminate all ignition sources. Separate from oxidizing materials. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabelled containers. **Appropriate engineering controls** : Use only with adequate ventilation.
