Section 3. Composition and ingredient information

Note: The hazard information listed is based on unbonded silica gel CAS Number 112926-00-8. To the best of our knowledge, the acute and chronic toxicological properties of bonded silica gels have not been investigated. This product contains synthetic amorphous silica, and should not be confused with crystalline silica such as quartz, cristobalite, or tridymite, or with diatomaceous earth or other naturally occurring forms of amorphous silica that frequently contain crystalline forms of silica.

Section 4. First aid measures

Description of necessary first aid measures

Section 5. Firefighting measures

Extinguishing media

Section 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

For non-emergency personnel : No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilt material. Shut off all ignition sources. No flares, smoking or flames in hazard area. Avoid breathing dust. Put on appropriate personal protective equipment.

Methods and material for containment and cleaning up

Section 7. Handling and storage

Precautions for safe handling

Protective measures : Put on appropriate personal protective equipment (see Section 8). Avoid breathing dust. Wear appropriate respirator when ventilation is inadequate. Section 7. Handling and storage

Conditions for safe storage, including any incompatibilities : Store in accordance with local regulations. Store in a segregated and approved area. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink. Eliminate all ignition sources. Separate from oxidizing materials. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabelled containers. Appropriate engineering controls : Use only with adequate ventilation.
