Section 3. Composition and ingredient information

Note: The hazard information listed is based on unbonded silica gel CAS Number 112926-00-8. To the best of our knowledge, the acute and chronic toxicological properties of bonded silica gels have not been investigated. This product contains synthetic amorphous silica, and should not be confused with crystalline silica such as quartz, cristobalite, or tridymite, or with diatomaceous earth or other naturally occurring forms of amorphous silica that frequently contain crystalline forms of silica.

There are no additional ingredients present which, within the current knowledge of the supplier and in the concentrations applicable, are classified as hazardous to health or the environment and hence require reporting in this section.

Section 4. First aid measures

Description of necessary first aid measures

Section 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

Do not touch or walk through spilt material. Shut off all ignition sources. No flares, smoking or flames in hazard area. Avoid breathing dust. Put on appropriate personal protective equipment.

Methods and material for containment and cleaning up

Precautions for safe handling

Wear appropriate respirator when ventilation is inadequate. Conditions for safe storage, including any incompatibilities : Store in accordance with local regulations. Store in a segregated and approved area. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink. Eliminate all ignition sources. Separate from oxidising materials. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabelled containers. Appropriate engineering controls : Use only with adequate ventilation.
