Personal precautions, protective equipment and emergency procedures

Conditions for safe storage, including any incompatibilities : Store in accordance with local regulations. Store in a segregated and approved area. Eliminate all ignition sources. Separate from oxidising materials. Keep container tightly closed and sealed until ready for use.
