Section 4. First aid measures

Description of necessary first aid measures

Personal precautions, protective equipment and emergency procedures

Section 7. Handling and storage

Conditions for safe storage, including any incompatibilities : Store in accordance with local regulations. Store in a segregated and approved area. Eliminate all ignition sources. Separate from oxidising materials. Keep container tightly closed and sealed until ready for use. Appropriate engineering controls : Use only with adequate ventilation. Use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits. The engineering controls also need to keep gas, vapour or dust concentrations below any lower explosive limits. Use explosion-proof ventilation equipment.
