## Section 4. First-aid measures

### Description of necessary first aid measures

## Section 6. Accidental release measures

### Personal precautions, protective equipment and emergency procedures

Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilt material. Shut off all ignition sources. No flares, smoking or flames in hazard area. ### Precautions for safe handling

**Appropriate engineering controls** : Use only with adequate ventilation.
