Section 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

Precautions for safe handling

Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabelled containers. Appropriate engineering controls : Use only with adequate ventilation.
