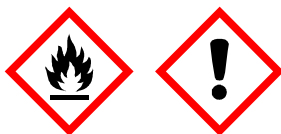

**SECTION 4: First aid measures****4.1 Description of first aid measures**

### 5.3 Advice for firefighters

### 7.1 Precautions for safe handling

**8.2 Exposure controls**
