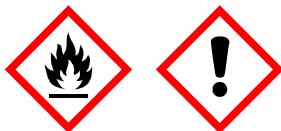

**SECTION 4: First aid measures**

**4.1 Description of first aid measures**

**5.3 Advice for firefighters**

### 8.2 Exposure controls

#### Appropriate engineering controls
