Agilent Drivers for Waters Empower 4.1 Software Site Preparation Checklist

Thank you for purchasing software from **Agilent Technologies**. CrossLab Start Up is focused on helping customers shorten the time it takes to start realizing the full value of their instrument system investment.

Correct site preparation is the key first step in ensuring that your instruments and software systems operate reliably over an extended lifetime. This document is an **information guide and checklist** prepared for you that outlines the software requirements for the system set up in your lab.

Introduction

Customer Information

- The Agilent ICF Support Layer for Waters CDS (WICF) is an instrument control application for the Agilent instrument portfolio running in Waters CDS and included in the Agilent Drivers for Waters Empower package.
- If you have questions or problems in providing anything described as part of Customer Responsibilities below, please contact your local Agilent or partner support / service organization for assistance prior to delivery. In addition, Agilent and/or its partners reserve the right to reschedule the installation dependent upon the readiness of your laboratory.
- Should your site not be ready for whatever reasons, please contact Agilent as soon as possible to re-schedule any services that have been purchased.
- Other optional services such as additional training, functional verification and consultation for user-specific applications may also be provided at the time of installation when ordered with the system but should be contracted separately.
- This document covers the Site Preparation to prepare for the WICF installation and/or to connect Agilent instrumentation into an existing Empower environment. The Waters CDS must be installed and functional before applying the Site Preparation for WICF.
- Waters is responsible for the Waters CDS deployment. Agilent is responsible for the WICF development and deployment.
- To use WICF in an Empower Enterprise environment, it must be installed on every LAC/E and client (or Terminal/Citrix server) interacting with the Agilent instrument, its methods, and results. WICF must not be installed on database servers or controllers with no Agilent instrument connection or interaction. For incremental upgrade scenarios the interoperability between different WICF and specific Waters ICF Support Layer versions is possible. More details are stated in the WICF Release Notes.
- WICF is compatible with Windows Terminal Server/Citrix environments. The Installation & Configuration Guide on the installation media of your WICF package contains installation instructions for the server deployment and instructions for silent installation mode for WICF. Please note and acknowledge:
 - The deployment of WICF to Waters CDS operated in Windows Terminal Server or Citrix backend requires administrative privileges and system oversight by the responsible system owner/IT function in your organization.
 - The standard scope of Agilent installation services does **not** include the deployment of WICF in Windows Terminal Server/Citrix configurations. Terminal Server/Citrix deployments are potentially accessed by many users and multiple

sites in your operation. The deployment activities must be well coordinated with the responsible system owner/IT function at your site to avoid disruption of your operation.

- If your organization requires the installation and configuration of Agilent WICF under Terminal Server/Citrix, please consult with your Agilent representative to plan the installation and to ensure the required resources are available.

Customer Responsibilities

Ensure that your site meets the following specifications before the installation date. For details, see specific sections within this checklist, including

- The **computing environment** and the necessary space is made available.
- Your site meets the **software, hardware, and networking specifications** described later in this document.
- Locate your **sales order information**, software authorization codes, and/or software licenses/certificates.
- Ensure that Waters Empower CDS is properly licensed with **ICLs and System Licenses** to configure and startup Agilent instrumentation.
- If purchased, locate, and activate the paper-based Waters Instrument Control License (ICL) via the Waters Licensing Wizard.
- If Agilent is delivering only Connection or Introduction services, the Installation of WICF including a passed Software Verification must be performed upfront, according to the product specific installation guide.
- Ensure to provide the following information at the time of installation/configuration to the service engineer.
 - Fixed IP address for the instrument (used for instrument configuration).
 - IP address and access to the instrument controller that will be connected to the instrument.
 - Planned Access Control Privileges for the system (used during system set up).
- The necessary **software media** are available.
- That a suitable **backup solution** is identified for your software.
- If Agilent is delivering **Installation, Instrument Connection or Introduction services**, users of the instrument system should be present throughout these services. Otherwise, they will miss important operational, maintenance, and safety information.

- Availability of a **system/network administrator** as needed to connect to your intranet and to perform installation tasks on a server environment (for example, Citrix).
- Availability of an **Empower administrator** having the privileges to connect and configure instruments.
- Please consult the **Special Requirements** section for other product-specific information.
- [Upgrades only] Ensure that the Waters ICF Support Layer 2.X, 3.X and the included components are correctly uninstalled before the installation of WICF.
- Ensure that your Agilent modules are supported by WICF and match the **minimum Firmware requirements** as well as the capacity recommendation documented in the WICF Release Notes. If Firmware updates are necessary, please contact your Agilent sales or service representative upfront.

- The below Network considerations only cover the communication between controller and instrument. For Network Specifications within the Empower environment, for example, Client or database, refer to the Waters documentation.
- Only Ethernet connection between the instrument controller and the instrument is supported. The exception is SFC instruments which use serial connections. To connect an instrument controller to an instrument, follow these guidelines:
 - Connect via an isolated switch using standard CAT-5 network cabling.
 - LAN communication hardware should be 100/1000 mbps (or higher) speed capable.
 - LAN communication must be on the same subnet as instruments, and preferably on the same segment.

- Please refer to the Release Notes on the installation media for supported hardware, software, instruments, and firmware requirements.
- If a firewall is in use other than Windows Defender, ensure that all required ports can be used by the Agilent drivers. For details, see the firewall section in the WICF Installation & Configuration Guide on the installation media.
- Compliance recommendation: If the lab is in a regulated environment, we recommend following the customer's standard operating procedures (SOP). The known and resolved Issues are listed in the Release Notes. Together with the Software Verification Tool, the Software Status and Release Bulletins, this may assist the customer to determine if any qualification tasks are required.
- Agilent offers the (re-)qualification of the hardware or the functional verification of the WICF driver installation/upgrade as an additional charged service. Please contact your Agilent sales representative for more information.
