Responsibilities during Review

- The Management of Agilent Technologies is responsible for the collection and presentation of energy consumption, greenhouse gas emissions data and water consumption to be reviewed by Trucost. Trucost liaised with Shawn De Angelo, Agilent's Energy & EHSMS/ISO14001 Programs Manager, to obtain the necessary data and support documents for validation.
- Trucost's responsibility, as agreed with the Management, is to use its specialist environmental knowledge to validate the data provided and assure it fairly reflects company activities and is stated in accordance with the environmental standards set out above.

Scope of Review

Trucost Plc has assessed the data covered by the scope of this statement as listed above using the following procedures:

- Assessment of Agilent Technologies' recently implemented environmental data collection software (E2MS).
- Verification of direct and indirect energy consumption data held within the E2MS system was performed by cross-checking against utilities bills provided via access to the company's corporate billing system (NISC).
- Assessment of savings realized from energy conservation and energy efficiency projects implemented by Agilent during FY2010 and by initiatives to generate and use renewable energy (i.e. solar power).
- Verification of GHG emissions calculated by the E2MS system or manually by Agilent was performed by ensuring the most recent and relevant emission factors were applied and the calculations were performed correctly.
- Verification of total water consumption data provided was performed by cross-checking against utilities bills provided via access to the company's corporate billing system (NISC) or via communication with the relevant sites.

Conclusion

On the basis of the work undertaken, Trucost believe that:

- The information for the environmental KPIs stated above has been fairly stated.
- The data presents a fair and balanced account of Agilent Technologies' material sustainability performance.
- Reporting is in line with both Environmental Key Performance Indicators: Reporting Guidelines for UK Business and World Resources Institute (WRI) and the World Business Council for Sustainable Development (WBCSD)'s Greenhouse Gas Protocol Initiative: Corporate Accounting & Reporting Standard.
