The plate is used for performing the high-resolution melt (HRM) calibration experiment on the AriaMx Real-Time PCR System. Calibration is required to use experimental HRM data for allele discrimination.

The plates are run in a melt segment on the AriaMx Real-Time PCR System to verify that the melting temperature of the EvaGreen-labeled product in each well meets specifications for accuracy and uniformity.
